Project No. FS-206 College of Business Legacy Hall The Florida State University

PROJECT DESCRIPTION

The project consists of the design of approximately 200,000 GSF of new space for a new College of Business for Florida State University in Tallahassee, Florida. It is envisioned that the new facility will accomodate students, faculty, and staff by creating a multi-functional, collaborative, and flexible environment to teach, research, and learn. Spaces to be constructed are classroom, instructional, ballroom and event, computer labs, distance learning and technology, Centers and Institutes, administrative spaces and building support functions. The selected design firm will provide master planning, program verification and coordination, design and construction documents, and construction administration, including BIM implementation. Master planning the site will be required to ensure future growth and expansions are planned for as well as connections to adjacent research facilities. Space for retail and commercial components may also be included as well as renovations to existing space needed to support the College of Business. Sustainable design/construction including LEED documentation will be required as part of basic services.

PROJECT BUDGET

The project budget is estimated at \$88,000,000 with a construction budget of \$65,000,000.

SELECTION CRITERIA

Firms will be evaluated in the following areas: current workload, location, past performance, volume of Florida State University work, design ability, and experience and ability. Criteria to be considered in the assignment of "Experience and Ability" scores include, but are not limited buildings, laboratory spaces, flexible lab spaces and administrative offices; expertise of the design team; and previous experience with projects utilizing the construction management delivery method. Firms will also be evaluated for special expertise in using BIM technology and sustainable design.

Design ability will be considered. Submittals should include examples of prior work which indicate design philosophies, sensitivity to site and surroundings, and aesthetic appeal.

For the purposes of this selection, firm location will be evaluated as follows:

- Firms whose managing office is located within the State of Florida will receive (1) point for location.
- Firms whose managing office is NOT located within the State of Florida will receive (0) points for location.
